The pass will be valid from the date of issue and expires twelve months thereafter. The pass must be shown on arrival at the Visitor Centre to allow staff to verify it and record the visit. The pass has no monetary value and cannot be exchanged for goods or other services at Rosslyn Chapel. If the pass is misused, Rosslyn Chapel Trust reserves the right to withdraw it from the holder.
